

RISK ASSESSMENTS - THINGS TO CONSIDER

TRAVEL

- FCO advice keep upto date
- Passports / Ehic Card dates are okay lost / stolen copies
- Insurance purchased timeously / policy carried
- Coach / Train / Ferry / Flights / Car delays / cancellations / missed / behavior of participants / fit for purpose / reputable recognised companies
- Luggage weight /size / lost / stolen
- Leader / participants late / not turned up
- E/Tickets safety / who carries; Mobile devices voltage / back up / lost / stolen
- Embassy details / Terrorism
- Health DVT / Dehydration
- Buddy system at all times / be aware & vigilant of general public and their behaviour & general public taking photos of girls

COMMUNICATION

- Parents emails / text / WhatApp / Skype / Facebook Group making to sure to ask security questions to identify those joining Social Media - awareness of Girlguiding Public Image
- Photographs / Videos permissions given
- Region Office /HQ contact details
- Embassy details / Local contact numbers
- Home contacts / emergency numbers
- Mobile devices Power supply / back up charges / Copies of documentations
- Ensure documentation sent to correct addresses /GDPR legislation
- Ensure use of correct tone / language at all times all leaders & participants

ENVIRONMENT

- Environment Extremes of weather hot /cold think rehydration / appropriate clothing / wide brimmed hats / sunscreen
- Wildlife / Nature suitable repellants
- Terrain appropriate footwear
- Terrorism / Crime local numbers FCO advice safe areas embassy details emergency cards - moneybelts
- Service project Confined spaces / Machinery / Materials paints / cleaning substances
- Age appropriate attractions
- Considerations for LGBTQ facilities / laws /correct terminology



RISK ASSESSMENTS - THINGS TO CONSIDER

FINANCE

- Insurance purchased
- Security / locked box / safety deposit box /money belts
- Travel Money Prepaid cards / Debit/credit cards -who has/takes / how is money distributed between leaders
- Briefing payments receipts / who manages / non payment
- Participants payments deadlines = who chases / items to book / buy
- Accounts accurate / up to date / monitored regularly to ensure guidance with Girlguiding Policies

CULTURE

- Awareness of Local Customs -food / bank holidays / religion / clothing (shoulders / legs / head) / LGBTQ - position in society of locals
- Local fees / levies that may need to be paid
- Local Laws drugs / medications
- Photographs restrictions / general public
- Language Barriers
- Terrorism / Crime FCO / Embassy / Stolen possessions' / personal attack / participant arrested
- Awareness of greetings / gestures from locals to the country

ACTIVITIES

- Instructors qualifications checked / behaviour of instructors
- Equipment checked
- Water activities swimming / suitability / sufficient buoyancy aids
- Suitable clothing for activity -climbing / trekking / swimming / walking footwear / hats / long sleeved - long legged
- Other people / General Public taking of photos
- Environmental conditions too dry / wet /dark / light



RISK ASSESSMENTS - THINGS TO CONSIDER

HEALTH

- Medication copies of prescriptions / enough medications for trip duration / translation cards
- Participant / Leaders illness prior to travel actions to take
- Allergies translation cards / Epipens & spares
- NHS Fit for Travel / FCO Advice / DR's Advice
- Local Facilities Dr's, dentist, hospital where / who will pay / who will go
- Injuries / Death who to contact / actions to take
- First Aid kit appropriate items carried / leaders qualified hydration sachets / bite repellents / treatments
- Medication Country / Local Laws can the medication be taken into country
- Accommodation Mosquito nets / repellent materials
- Extreme conditions heat / cold hydration sachets
- Mental Health signposts to appropriate agencies / Leaders to consider Mental Health First Aid Training.
- Safeguarding leaders qualified, nominated safeguarding lead for the trip, National Safeguarding team and Region team contacts to be held
- Healthcare plans to be in place as necessary.

FOOD

- Drinking water / Ice / Sterilising Tablets
- Allergies EpiPen's / translation cards
- Food preparation / contamination / cleanliness
- Equipment / Knives
- Camping / Water Buckets / open Fires
- Consider cultural needs, e.g. Halal

ACCOMMODATION

- Fit for Purpose /Suitable / Approved
- Shared accommodation safety of participants / facilities (own / shared toilets / bedrooms), LGBTQ considerations
- Security Documents / money / personal possessions
- Fire exits / escape routes
- Electrical items voltages
- Bedrooms bunk beds / flooring
- Sanitation wet floors / types of toilets / hygiene / cleanliness
- Kitchen equipment / knives / water
- Camping Tent pegs & poles / guy ropes / level ground / water / Girlguiding allows?
